## COP 26: TACKLING THE EFFECTS OF CLIMATE CHANGE

**Councillor Peter Skelton has written a brilliant and informative article on COP 26 which we urge you to read on our website, this is an edited version.**

**1. What's the problem?** As the latest report of the International Panel on Climate Change (IPCC) concludes 'Human-induced climate change is already affecting many weather and climate extremes in

every region across the globe. Evidence of observed changes in extremes such as heatwaves, heavy precipitation, droughts, and tropical cyclones, and, in particular, their attribution to human influence is strengthening'.

Here's how the Earth's climate system works. Sunlight heats the Earth's surface, which in turn warms the atmosphere





with heat gradually lost out to space. However, the average temperature of the atmosphere at the Earth's surface i.e. 'global mean surface temperature' changes in response to fluctuations in the energy coming in from the sun, which we can't change, but also from changes in what's in the atmosphere.

In particular, 'greenhouse gases', notably carbon dioxide trap more heat in the atmosphere thus increasing the Global Mean Surface Temperature. We humans are the chief cause of historically increasing levels of CO<sub>2</sub> in the atmosphere, much of it derived from the burning of 'fossil fuels' (coal, oil and gas).

**2. Whose responsibility is it to tackle the climate problem?** The short answer is that it's down to all of us. After all, it is we, especially in the richer parts of the world, who have caused the problem in the first place.

At the highest level, world governments have a vital responsibility to ensure we limit the increase of global mean surface temperature to within 1.5°C – beyond which the combined effects of accelerating climate heating and sea-level rise may prove beyond our ability to cope – by reaching internationally binding agreement on measures to limit

greenhouse gas emissions at the 'COP 26' meeting in Glasgow next month (26th meeting of the Conference of Parties hence COP 26). At the national level, the UK parliament declared a Climate Emergency in May 2019, as did Milton Keynes, though unfortunately it has no binding effect on the UK government. We now await a climate change and ecological emergency bill requiring the UK 'to take responsibility for its fair share of greenhouse gas emissions, to actively restore biodiverse habitats, and to stop damaging our natural world through the production, transportation and disposal of the goods we consume'.

**3. So what can we do to help here in Woburn Sands?** In January 2020, Woburn Sands Town Council resolved to support MK Council's Declaration of a Climate Emergency, and in the following month established a 'Woburn Sands Climate Change Group', with membership drawn both from within the Town Council and from the local community. The group has explored a number of possible ways of reducing our local community's net greenhouse gas emissions, such as the planting of street-trees, traffic-calming measures with improved scope for cycling and walking, and improving the condition and biodiversity of local environments. So next month, we'll be carrying out a consultation of the local community – to coincide with COP 26 – to gauge the strength of support for these proposals, to determine which ones we can progress with.... **Watch our website!**

On **Sunday 14h November** we look forward to welcoming a small group from Woburn Sands Band, with representatives of civic and uniformed organisations to our **Remembrance Sunday service** at 9.45 a.m. Please get in touch with me if you plan to bring a group from your organisation and have not yet made contact with us. We need to ensure that we avoid crowding in the church in order to keep everyone safe. We are working with the Town Council and Churches Together on preparations for the Act of Remembrance

at the War Memorial which focusses on the two minutes' silence at 11.00 a.m.

This year we plan to hold all of our usual **Christmas services**, including a Christingle at 3.00 p.m. on Sunday 5 December, Carol Service at 6.00 p.m. on Sunday 19 December and Crib Service at 4.00 p.m. on Christmas Eve.

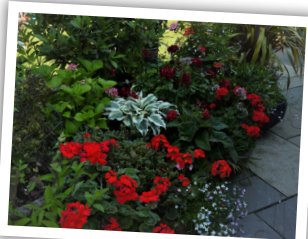
# SUMMER GARDEN COMPETITION

# EXCITING NEWS - WOBURN SANDS YOUNG ENVIRONMENTALIST AWARDS

Please let all your friends and family know that we are starting out on a new venture aimed at the children and young people in our community.

Look out in schools, activity groups, in the library, on our notice boards and Town Council Website <http://www.woburnsands.org.uk> for lots more information in the coming months about the Woburn Sands Young Environmentalist Awards. But just so that you have a really good idea of what we are planning, who can enter and how to enter here are some quick pointers and a whistle-stop tour of the why, what, how and when of this important new venture for our town. So please do all you can to help us to get the word out about the **Woburn Sands Young Environmentalist Awards – YEA!**

## Why set up a Young Environmentalist Award?

It is important to showcase the positive environmental actions of the Children and Young People of Woburn Sands. No better time than now to draw attention to Children and Young People's own purposeful environmental contributions - whether it be at school, at home, or as part of other activities. We want to recognise the determination they have to improve the environment and share their knowledge, experience, and enthusiasm with all the members of our community. This is one way of offering our support to



the younger members of our community who, like thousands of other children and young people who have been surveyed worldwide, are likely to be worried about the health of the world they are growing up in. We want to support their wellbeing and provide them with the opportunity to share their environmental actions and creative solutions through the Award process.

## What

We will be looking for entrants for the award to capture and report on environmental action or activity they are involved in from the smallest to the largest as it can all make a positive contribution. Perhaps this will relate to one of the following themes: Climate Change, Plastic Pollution, Litter, Wildlife, Recycling or Nature but we would really welcome other ideas that are clearly in line with the Young Environmentalist ethos and ideal which is to be *'Actively involved in creating a better environment.'*



## How

Entrants themselves will determine how to record and report on their activity. That might be visual evidence such as photographs, drawings, a collage, a piece of artwork or a video while others may prefer written evidence such as an essay, journal, or project notebook. These are just suggestions, and we will be open to receiving as many types of entry as possible including the use of new technologies to record evidence.

Everyone who wants to take part will need to have the permission of a parent or guardian and to fill in an entry form which will be widely available both in paper form and electronically. We will not be able to accept any entry without a completed entry form.

## When

Because we know that different types of environmental actions have very different time scales, we thought it was important to let Children and Young people know about the award well in advance of the need to submit evidence. This way they can be thinking about what activity they want to record and when.

**Entry forms should be widely available from the start of 2022. The closing date for submissions will be Friday 29th April 2022** and the awards will be made in June 2022. Those providing the necessary evidence of their actions/activities will be awarded a WSTC Young Environmentalist Certificate. We hope to have some special prizes for the

top entries, and we plan to showcase as many of the activities as possible on, for example, the WSTC website, via WSTC Social Media, the WSTC Newsletter and hopefully at a WSTC event.



## REMEMBRANCE DAY SUNDAY 14th NOVEMBER

# WOBURN SANDS ELECTRIC VEHICLE & VEHICLE CHARGING SURVEY

Milton Keynes is one of the most advanced local areas when it comes to the provision of electric vehicle charging infrastructure, having installed over 400 charging points in the past 6 years including 6 in our own car park.

To help residents of Milton Keynes make the move to electric vehicles, Milton Keynes operates the Electric Vehicle Experience based in the Centre: MK, where residents can get independent advice on electric vehicles and their charging and the chance to test drive some different vehicles. With a ban coming on the sale of new petrol and diesel driven cars coming in in 2030, you may have bought your last fossil fuel car!
