


SEMK PLANNING APPLICATION OBJECTION LETTERS

NEEDED! Future Development of Woburn Sands (SEMK) is up for grabs

The most recent planning application to hit the town has gone live. Most residents of Woburn Sands will have received a yellow and black leaflet before Christmas which announced a scheme from L & Q Estates Ltd and Fox Land & Property Ltd about their plans for developing part of the SEMK site as if their scheme was a fait accompli.

The application to Milton Keynes Council (22/00524/OUTEIS) for land west of Woburn Sands and east of Bow Brickhill has now been put out for consultation and comments. Woburn Sands Town Council is **fighting this application** as it does not bode well for the town's future in terms of its social cohesiveness, its unique character, its traffic management, its future amenities and its links to the new development.

Below is a map of the site and clearly shows **that it does not include the whole area of the SEMK** which Woburn Sands Town Council had previously endorsed as being a comprehensive concept, benefitting the town and its residents.



Woburn Sands Town Council recommends that this present application **is refused** by Milton Keynes Council on the following grounds:

1. The application **does not comply with the Supplementary Planning Document** (SPD) for SEMK which was approved by MKC in Jan 2022 after comprehensive discussion with the neighbouring parishes of Woburn Sands, Bow Brickhill, Wavendon and the Walton Community Council.

2. The application is not a comprehensive plan for the whole site but merely develops portions of it in a haphazard, non-integrated manner, cherry picking the elements which are most attractive to the developers.

3. The application **does not reflect the distinct characteristics of Woburn Sands**, Bow Brickhill and Wavendon as per the recommendations in the SPD, nor does it create a thriving community set within a lush landscape with significant planting of forest scale trees that give the sense of extending Brickhill Woods into the Milton Keynes urban area. Thus, the Vision of the SPD is compromised, again persuading Woburn Sands Town Council **to recommend refusal**.

4. The site applied for will be isolated from the rest of Milton Keynes as there are no access points linking it to the rest of MK to the north but instead 3 or 4 access points to the south onto Bow Brickhill road, funnelling vehicle traffic towards and through Woburn Sands. This is contrary to the SPD which attempts to limit the traffic likely to come through Woburn Sands by reducing access from the SEMK site to the Bow Brickhill Road.

5. In terms of the housing type, the application proposes a **high housing density** of over 40 houses per hectare with more than 50% being 1 or 2 bedroom units, giving a potential for social problems in the future. Housing density is higher than Broughton, which is identified by MKC as a high density area.

6. By siting playing fields to the west of the site, furthest from Woburn Sands, the developers will jeopardise the much needed playing fields and green buffer zone adjacent to Woburn Sands nearest the fishing lake, which was an essential part of the SPD and welcomed by Woburn Sands Town Council.

7. Other than inadequate on-line information questionnaire and following the forementioned leaflet drop, the applicants have not carried comprehensive consultation out with the local community - they have not staged any public meetings or exhibitions in Woburn Sands and their discussions with the Town Council have been notably absent. Woburn Sands Town Council are happy to play an active role in further discussions to develop the whole SEMK site as per the SPD if they are consulted.

There is still time for you to respond to

this planning application and we very much hope you will do so. Ignore the deadline date on the MK website as all responses received before the crucial Development Control meeting must be considered and that won't be for some weeks yet. You can see the Town Council's full response on our website. This response sets out in detail why Woburn Sands Town Council is recommending the planning application be refused.

FROM IAIN STEWART MP

I remain deeply concerned about South-East Milton Keynes development plans –

notably around Woburn Sands and Bow Brickhill. Principally I am worried at the lack of alignment and cohesion between Milton Keynes Council's obsession with an enormous housing expansion, with other considerations such as East-West Rail and the wider Oxford-Milton Keynes-Cambridge Arc. I remain to be convinced that there is a need for such urgency or scale of expansion. There is time to reflect carefully for what size and style of development is appropriate; we do not need more massive, high density estates that will be out of character with the surrounding area and existing housing areas. I hope Milton Keynes Council will start to listen.

I will continue to ensure resident's concerns are being heard by the relevant stakeholders in SEMK. I engage regularly with East West Rail and Network Rail about the crossings in Woburn Sands and Bow Brickhill, as well as on East West Rail issues as a whole. I remain in communication with businesses in Caldecotte and Tilbrook about MK Council's grid road extension policy. Also, I am speaking with the new Minister of State for Housing at the Department for Levelling Up, Housing and Communities, Stuart Andrew, about what is happening in SEMK and how the Government can help in this matter.

SUPPORT FOR HIGH STREET BUSINESSES

Following the initial leaflets advertising the shops and businesses along the High Street and Station Road which were distributed to all residents in Woburn Sands and surrounding villages before Christmas and the successful rollout



of the Woburn Sands High Street Tote Bags, there is now a new noticeboard in the Russell Street Shoppers' Car Park which will have a map and list of shops etc to promote the High Street and any new initiatives of the shops and businesses.

The information will reflect the dynamic nature of the businesses in the High Street. All shops and businesses who have new products they want to promote, new events coming up etc are welcome to bring their advertising material to the TC office so that it can be displayed for all to see. Please try to make the material space friendly (ie A5 or less) as we anticipate quite a lot of demand and space will be limited.

Both of these initiatives have been funded by a Regeneration Grant from Milton Keynes Council which the



Council received last November. We are hoping to apply to MKC for further funding for new initiatives to support the High Street in the coming months.

If you haven't been given or received one of the Tote Bags, then you haven't missed out- they will be available to pick up on Mowbray Green on Saturday 4th June at the Queen's Jubilee Celebrations (until supplies run out!).



EAST WEST RAIL LATEST INFORMATION

At the start of April Five Councillors from Woburn Sands Town Council met with three representatives from EWR to discuss current progress on the EWR project. Over 160,000 comments were received from almost 10,000 returned questionnaires sent in from the whole project area as part of the Non-Statutory Consultation that took place last year. Of these, they estimated that almost 6,000 of the comments came from people living in and around Woburn Sands. We were assured that every one of the comments were read and will be taken into account before the next stage of the Statutory Consultation is published in late 2022/early 2023.

When this happens, it does not mean the end of community engagement – further comments will be welcomed and considered. So, there is an opportunity for you to give more feedback at this stage. EWR asked us to tell you that they welcomed each and every one of the comments received from Woburn how and know carefully Sands everyone had thought about their responses. They were impressed both with their quantity and quality. The Town Council would also like to thank everyone for being so proactive on such an important issue. They are working in collaboration with neighbouring villages and communities to get the best solution for Woburn Sands. We are still pushing for a resolution to the problem of the level crossing while standing firm against any notion of a Woburn Sands by-pass.
